RESTRICTIVE COVENANTS

Harrico Corporation, a North Carolina corporation, the owner in fee simple of the real property now duly platted as "Section No. 1 of Lake Forest Estates" as said plat is now recorded in the office of the Register of Deeds of Randolph County, North Carolina, in Book 14, Page 69, hereby makes the following declarations as to limitations, restrictions, and uses to which the lots and/or tracts constituting said subdivision may be put, hereby specifying that said declaration shall constitute covenants to run with all the land, as provided by law, and shall be binding on all parties, corporations, and all persons or firms claiming under them, and for the benefit of and limitations upon all future owners in said subdivision, this declaration of restrictions being designed for the purpose of keeping said subdivision desirable, uniform and suitable in architectural design, and to insure the use of the property for attractive residential purposes only, to prevent nuisances, to prevent the impairment of the attractiveness of the property, to maintain the desired tone in the community, and thereby to secure to each site owner the full benefit and enjoyment of his home, with no greater restriction upon the free and undisturbed use of his site than is necessary to insure the same advantages to the other site owners. Anything tending to detract from the attractiveness and value of the property for residence purposes will not be permitted. The restrictive covenants are as herein specified:

1. All lavatories and/or toilets shall be built indoors and connected with an outside septic tank which shall be approved by the Randolph County Health Department, until such time as a sewer system shall be maintained, at which time the purchaser, his successors or assigns, agrees to connect said premises therewith without delay.
2. No more than one residence may be built on any one lot.
3. No manufacturing or commercial enterprise, or enterprises of any kind for profit shall be maintained upon, in front of, or in connection with any of the lots in said subdivision, nor shall said lots in any way be used for other than strictly residential purposes.
4. No nuisance, or offensive, noisy, or illegal trade, calling, or transaction shall be done, suffered, or permitted upon the lands in said subdivision, nor shall any lot or part of said subdivision be used or occupied injuriously to affect the use, occupation, or value of the adjoining or adjacent premises for residence purposes, or the neighborhood wherein said premises are situated.
5. No swine shall be kept or maintained on said property or any portion thereof, nor shall any chicken yard be maintained thereon.

6. No billboards, sign boards, or unsightly objects of any kind shall be maintained on said lands in this subdivision or any part thereof.

7. No trailers or mobile homes will be permitted on any of the lots in this subdivision.

8. No junk cars will be permitted upon any of the lands in this subdivision.

9. No structure shall be erected or placed on any lot unless a said structure shall have at least 1200 square feet of living area exclusive of carports, garages, and porches.

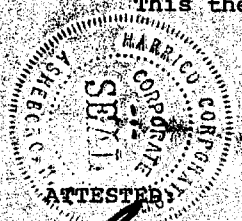
10. No buildings shall be located on any building lot nearer than 20 feet to any side lot line, or within 75 feet of the front line of each lot.

11. There shall be no cinder or cement blocks visible on any structure place on any of the lots in this subdivision.

12. No land owners in the tract shall maintain any offensive or dangerous pets.

These restrictions and reservations are made for the benefit of any and all persons who now may own, or who may hereafter own, property in this subdivision, and such persons are specifically given the right to enforce these restrictions and reservations.

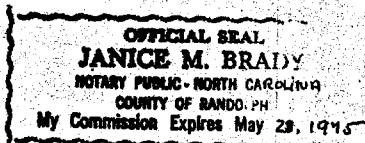
