AMENDMENT TO  
DECLARATION  
OF  
LIBERTY COURT CONDOMINIUMS

PHASE II

THIS DECLARATION, made on the date hereinafter set forth by George Clements Building, Inc. a North Carolina corporation of Randolph County, North Carolina, hereinafter referred to as "Declarant."

WITNESSETH:

WHEREAS, Declarant is the owner of certain property in the City of Archdale, County of Randolph, State of North Carolina, which is more particularly described as:

BEING all the units and all of the Common Area located in Phase II on the plat entitled LIBERTY COURT CONDOMINIUMS, PHASE II duly recorded in the Office of the Register of Deeds for Randolph County, North Carolina in Condominium Plat Book 1, Page 9.

WHEREAS, said property will constitute Phase Two of Liberty Court Condominiums;

AND WHEREAS, Declarant will convey said property subject to certain protective covenants, conditions, restrictions, reservations, liens, and charges as set forth in that certain document entitled "Declaration of Condominium of Liberty Court Condominiums, Phase I," recorded in Deed Book 1359, Page 1188, Randolph County Register of Deeds, which documents and the contents thereof are

incorporated herein by reference and made part hereof as fully as though the same were set out in their entirety.

NOW THEREFORE, Declarant hereby declares and establishes that all the properties described above shall be added to the plan of dwelling ownership and governed by the provisions of the "Declaration of Condominium of Liberty Court Condominiums, Phase I," recorded in the Office of the Register of Deeds of Randolph County, North Carolina in Deed Book 1359, Page 1188 as amended, which as above stated are incorporated herein by reference.

FURTHER, Exhibit "B" of said Declaration is hereby amended to read as follows:

\* The minimum percentage of interest in common areas and facilities has been computed to show the maximum possible dilutive impact on unit owners' interests in such areas. The Declarant has reserved the right to construct up to 40 units in the Condominium pursuant to Article 5 of the Declaration. For this purpose, it has been assumed that (a) the balance of the units which may be constructed will be constructed; (b) units to be constructed consist of 24 two-bedroom units; (c) the internal layout and external configuration of such units are not varied from the existing units; and (d) the fair market value of existing units remains proportionate to and approximates the fair market values of those units subsequently built at such time. These figures may vary depending on the actual construction of subsequent units. The inclusion of this information shall not be construed as an undertaking by the Declarant to build any units other than those of existing phases, nor a representation by the Declarant that units which may be built will not vary architecturally or in their internal layout and external configuration from those of existing phases.

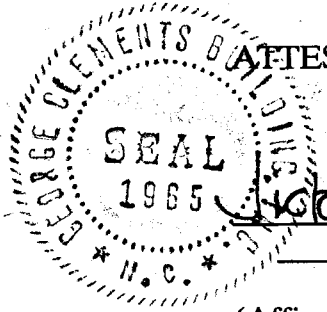
