KNOW ALL MEN BY THESE PRESENTS that J. C. Richardson and wife, Maude O. Richardson, and E. S. Conroy are the owners and developers of Section One and Section Two of Hidden Forest Subdivision, maps of which are duly recorded in the office of the Register of Deeds for Randolph County, N. C., in Plat Book 11, at Pages 25 and 26, and do hereby covenant and agree with all persons, firms or corporations now owning or hereafter acquiring any property in said subdivision, that Tracts 1 through 10 of Sections One and Two in said subdivision are hereby subject to the following restrictions as to the use thereof:


The restrictions imposed hereby are as follows:

1. This property shall not be used for any business or commercial use.
2. No residence shall be built nearer the front property line than 40 feet or nearer the side property line than 10 feet.
3. No hog pens shall be placed on said tracts nearer than 300 feet to any street.
4. There shall be no outside toilets permitted on the property and all sewage disposal shall be made through the use of approved septic tanks.
5. No residence shall be built upon less than a minimum of four units, or 20,000 square feet, as set out in the plat herein referred to.
6. No residence shall be built that shall have less than 850 square feet of floor space on the first floor exclusive of carports, porches or garages.
7. There shall be no junk automobiles allowed on the property.
8. Exterior walls of cement block houses must be painted or stuccoed.
9. There shall be no trailer homes of any kind permitted on the property.
10. There shall be no shell homes of any kind permitted on the property.
